## **County Councillor's Report**

## **Speed Limit Review**

I have received copies of all the legal documents required for the speed limit changes and works are scheduled to commence on the various sites Monday 26 March 2012 and are planned to be completed by April 13th. At the time of writing I have unfortunately seen no evidence of this, but I hope that by the time you read it everything will be in place!!? After an implementation period the new limits are formally reviewed again to assess their effectiveness, all as part of the due process, but I don't know when this will be. This review was first proposed in 2003, and begun about 2007.

#### Bucks introduces more charging for home to school transport

From September the County will introduce transport charges for any pupil not attending their nearest 'appropriate' school. This does not mean school which you have chosen or been selected for, but school which is capable of delivering you the required educational attainment. All upper schools are considered as being able to provide an education to a grammar school qualified pupil. (A grammar however is not deemed suitable for anyone who has not qualified)

In effect unless you need a special school, and live more than three miles from your nearest school, Bucks will only pay for you to go to your nearest upper school within the county boundary. Tring School and one or two others currently attended outside the county boundary are included in this arrangement, so those getting free transport to Tring already will continue to do so.

Last year far more draconian and inconsistent charges were proposed and withdrawn, except for sixth formers and out-of-catchment pupils who are currently paying large fares. This level of charging for younger pupils was reconsidered as a result of responses to those proposals, and some loud objections from people such as myself, but it is now proposed to phase in the charges, at a much reduced rate. Charges will be introduced at £10 per week to pupils about to start secondary this September, and £2 a week administration charge for pupils in years above already with travel places to schools not their nearest.

#### New arrangements at the household waste recycling site

Bucks County Council has awarded a new contract to operate these sites, with some changes.

Form 1st April the sites will open an hour later and have fixed summer and winter opening hours. From 1 April -30 September summer opening times will be in place and all the sites will operate from 9am - 6pm. From the 1 October -31 March, winter opening hours will be in place and the sites will operate from 9am - 5pm.

The second change which will be introduced on-site is an improved reuse service, which is going to be phased in over the coming months from April 2012 – July 2012. This will include a shop at the Aston Clinton site. Materials suitable for reuse will be collected from the county's recycling centres and sold. These details are being finalised by the contractor and their partnering charity organisation and will be publicised as soon as completed.

The new contract will also provide enhanced customer experience with 'meet and greet' attendants available to help customers unload waste to ensure items are recycled and reused. Users of the site will also notice new signage and improved layouts of recycling containers.

## Local Area Forum May 15th St Michaels School Stewkley

Agenda items for this forum (yet to be confirmed) are proposed to include the community environmental toolkit, developed by Community Impact Bucks and BCC, Luton Airport expansion proposals, and the annual report to the LAF from London Midland trains.

Councillors have looked at the model S106 Agreement and changes to the criteria, which they feel appropriate, have been passed onto AVDC.

### **Neighbourhood Plan**

Cllrs Cubbage, Wilkinson and Holt attended a meeting with AVDC to discuss the implications of developing a Neighbourhood Plan. The Parish Council have greed to defer any further action until the draft of Aylesbury Vale Development Plan is published. It was agreed to give information to parishioners via e-mails and the website.

## **EDaN Report**

The Beautification Team are considering ideas as to what to place at the foot of the Edlesborough Village sign and to create a 'Then & Now' of Edlesborough parish.

Bus Transport team are investigating the acquisition of a Community Bus to be shared with other parishes.

The Traffic Management Team are continuing to discuss the option of replacing Speedwatch with a Sentinel device which does not require anyone in attendance.

The newly formed 'Friends of the Church on the Edlesborough Hill' are currently deciding on priorities such as a Manager/Key Holders, Cleaner etc. A meeting has been arranged with the Regional Director of The Churches Conservation Trust on 10<sup>th</sup> May. A concert by Dagnall Choir has been arranged for 30<sup>th</sup> June commencing at 7.30pm with West Gallery Quire in the morning.
