District Councillor's Report

District Cllr Chris Poll's report

I would like to start this month's report with the latest discussions on next year's level of council tax charge for AVDC. Cabinet met on Tuesday and agreed to the proposal to refuse the government offer of a 1% compensation for those authorities that freeze their tax. As I have said before, the problem with accepting the government grant is that it is for one year only and because AVDC took the freeze grant of 2% last year this would mean a 3% loss going forward. The proposal will be put to full council next month and I am minded to vote with cabinet's proposed rejection of the freeze grant and accept the 2% increase in AVDC's precept. This would mean an increase of £2.62 to a band D property's annual council tax bill. The Communities Secretary made his announcement on Local Authorities (LA), settlement yesterday and thorough scrutiny of its contents are being carried out but it appears that the bare bones of what I have said here are correct. The implied retention of some business rate by LA's will be looked at by my scrutiny committee as to whether this may be taking with one hand and giving back with another though. If this is indeed new money, there may well be a case for accepting the freeze grant.

I will gladly listen to residents thoughts on this and form my final opinion between now and the next full council in February.

On Parish precept I examined closely what happened in Cheddington before I sat on the Parish Council. The previous council found itself with a funding shortfall due to many years of precept freeze and proposed a large increase. It went out to consultation through the village publication explaining what was intended and no objections were received. In fact many positive comments were sent to the council. Besides the large increase a 3% annual increase was planned and implemented. This has enabled a 10 year programme of street light replacement as well as the partial funding of a new footpath along with funding from section 106 money and a grant from the LAF.

I will summarise the adoption of the New Homes Bonus (NHB) policy which was voted for at full council 2 weeks ago but have included a full explanation with my written submission to Lin.

AVDC will retain all their share of any NHB in future but set aside 20% into a fund which communities can bid for. The criteria will be to offset any extra demand on local services or infrastructure created by new housing. This would mean that spending on infrastructure caused by development in one settlement can be spent in another. AVDC is one of only 2 councils in the country that will share some of the NHB monies to communities directly.

On waste and recycling I would like to reiterate that your bin men will not take any side waste. If you have more than a bin full of waste or recycling you should either retain it for the next collection or take it to your local recycling centre. Residents should be aware that recycling left uncovered outside their properties may give clues to expensive gifts so all side waste should be hidden from view. With regard to the compostable liners for your food waste caddy I can confirm that AVDC will not be supplying more bags. These are available at supermarkets. Please only use compostable bags.

If you are away from your property for any time during the Christmas holidays then a timer for lights can be used to give the impression you are at home. Also perhaps ask your neighbours to keep an eye on your property and park any vehicles in a way that would make it difficult for thieves to access the exhaust system as there is a spate of Catalytic Converter thefts at present.

I attended a recent Luton Airport meeting and was informed that the Noise Monitoring Van would be in Dagnall during April/May 2013.

Finally I would like to wish all residents of Edlesborough, Dagnall and Northall a peaceful Christmas and prosperous New Year.

Cllr Poll confirmed to the Chairman that Parish Councils would still be entitled to appropriate S106 Payments notwithstanding the new arrangements for the New Homes Bonus scheme.
