#### **District Councillor's Report**

From June 2012 Buckinghamshire County Council handed over management of lvinghoe Library to a community Management committee and it became the Beacon Villages Community Library. As an independent charity the

Library will need to find funding for the service and it is looking for support not only with fund raising but also for volunteers.

From April 2013 the government has announced that council tax benefits will no longer exist in their current form Instead councils will need to operate a local council tax support scheme. AVDC are currently considering how it will

Implement a new system of council tax discounts to replace council tax benefit. Once a detailed scheme has been will be in place from April 2013.

AVDC are asking Aylesbury Vale residents to decide whether or not to 'opt in or opt out' of the commercially available Electoral Registration form when completing their Electoral Register form. Choosing to opt out will mean they will not be included on the edited version of the register which is available to be sold to anyone who applies to the Council.
