EDaN Project

Cllr Williams had brought in the plaque and tree which had been presented as an award by ADVC in recognition of the preparation of the Parish Plan.

EDaN had obtained the services of a new Treasurer

Production of the Village Sign for Edlesborough was well advanced and a suitable location on the Green had been chosen and the May 1st celebrations being organised.

EDaN were resuming discussions with Bucks CC regarding the Beautifying of Dagnall roundabout.

Tickets for the Concert to be held at St Mary's Church, Edlesborough would be £7.50 for adults and £3 for the under 16 year olds. Help was promised by Thames Valley Police to assist in getting people across the A4146.

The Cycleways Team are seeking funding and have a representative from Bucks CC who has joined the team.

There is difficulty with forming a Youth Group, youths of the Parish are urged to contact anyone of the EDaN project teams if they are interested and have ideas to put across.

Speed Limit Review

The Consultation period is now underway. The Council discussed and supported most of the proposals given by Bucks CC many of which Edlesborough Parish Council had previously submitted. It was however proposed by Cllr Williams and seconded by Cllr Mrs Prys-Jones, with one objection, that the A4146 from the Travellers Rest to the Edlesborough 30mph speed limit be reduced to 40mph from the existing national speed limit (60mph) that Bucks CC have recommended. Also proposed by Cllr Williams and seconded by Cllr Brown that a 40mph speed limit should be introduced on the A4146 south into Dagnall, a 40mph speed limit from Northall to the parish boundary towards Leighton Buzzard and 40mph speed limit from the 30mph speed limit through Dagnall to the Parish boundary towards Hemel Hempstead, to which Council agreed. These proposals would result in a 40mph speed limit between the Parish boundaries between Hemel Hempstead and Leighton Buzzard with the existing 30mph speed limit through Dagnall and Edlesborough and the current 40mph speed limit through Northall being reduced to 30mph.

General Purposes Committee Report

The GPC committee had agreed in principle to certain alterations to the Memorial Hall put forward by the Under 5's provided they could obtain the appropriate funding.

A quotation had been accepted for the re-decoration of the Memorial Hall main hall.

Committee were still considering the quotations received for replacing the boilers.

Cllr Brown had prepared a 'Vision' statement regarding the Pavilion and would be holding meetings with interested parties. A meeting would be held with The Churches Conservation Trust to discuss various issues with Edlesborough Church.

Northall:: Council, with the Landlord's consent, would be entering 'The Swan' public house at Northall in the

Bucks CC 'Pub of the Year' competition.

Edlesborough: Waiting for indication on costing for extending the lay-by in Brook Street

Dagnall: A streetlight column and light were damaged towards the end of December, beginning of January.

Clerk endeavouring to establish how this occurred and who was responsible for cutting down the

column.

Dagnall The Council will be having a stall at the Dagnall Fete to be held on 19th June commencing 3pm where

Litter Bin posters will be available and children able to enter a colouring competition.

Northall: Residents have been requested to clear the ditches adjoining their properties in Leighton Road and

Bucks CC will be jetting the culverts.
