General Purposes Committee Report (GPC) incl. Churchyard

All Councillors were in receipt of the draft Minutes of the GPC meeting held on 7th December and various matters that were discussed were reported by the GPC Chairman. The main item was the application for funding for replacement of the Memorial Hall floor which would be sent off early in the New Year to both AVDC and Awards for All.

A further site meeting to be held in January to discuss the Cemetery Access project.

The Parish Council were devastated to learn of the vandalism caused this week to the recently sited donated Seat in front of the Pavilion on The Green. This would be re-fixed in due course, Police Patrols would be requested to ensure the seat is not uplifted again and the Parish Council will not hesitate to prosecute those responsible for any further damage. In the meantime the Parish Council are investigating the cost and installation of a Kick Wall.

Traffic Calming Reports

Yellow Backed Signs have been erected throughout the Parish with roundels and dragons teeth expected shortly.

Edlesborough:. A Parishioner had sent an e-mail to the Parish Council concerning and Anti Social Behaviour issues in Edlesborough. The PCSO would be asked to look into this and respond.

Permission given for a Neighbourhood Watch sign to be erected on the lamp post in Orchard End.

Neighbourhood Action Group

Minutes of the previous meeting had been received. Thames Valley Police were re-organising their staff to provide a permanent neighbourhood officer for the area who would not be used as a response office. Both Pitstone and Edlesborough Parish Councils were concerned about the PCSO's duties and the 50% costs being paid and have requested written clarification from Insp. Anne Jones on this issue. The PCSO now has regular contact with the Eaton Bray PCSO and she was expected to be kept in the picture if there are any plans to renew the dispersal order.

The PCSO is also keeping a look out for cars that night be involved in drug dealing. The next meeting will take place on 24th January 2007 at Edlesborough Memorial Hall.

<u>Cemetery</u> Approval given for the purchase of further grave markers for 2 more rows.
