Accounts

The Clerk summarised the end of year accounts to the full council.

Council had budgeted for a small surplus of income over expenditure in the year ended 31 March 2018. The actual figure was £25,484. Currently EPC has reserves of £183,201.94 most of which is allocated to be spent on ongoing projects.

- Street lighting within the parish.
- Traffic Calming proposals in both Edlesborough and Dagnall.

Cllr Mineikis thanked the Cllrs, District & County Cllrs, Thames Valley Police, the Clerk and the many volunteers who aid the Parish Council throughout the year; ECSC, EDaN Teams, Allotment Wardens, Charity Trustees, the Council contractors and the parishioners who help to keep the village tidy.
