## St Mary's Village Carnival

Edlesborough Parish Council and Eaton Bray Parish Council will have a joint stall at the Carnival. The Councillors look forward to meeting parishioners, answering questions and hearing suggestions.

### Inconsiderate Parking in the Villages

Council reminds drivers that inconsiderate parking causes a danger to other road users, pedestrians, and wheelchair users.

The rule 243 of the highway code states **DO NOT stop or park**:

- near a school entrance
- anywhere you would prevent access for Emergency Services
- opposite or within 10 metres (32 feet) of a junction, except in an authorised parking space
- where the kerb has been lowered to help wheelchair users and powered mobility vehicles
- in front of an entrance to a property
- on a bend

**except** when forced to do so by stationary traffic.

The Parish Council regularly receives complaints about inconsiderate parking in the villages. Before you park please take a moment to think will my parking:

- Obstruct the view of a driver or pedestrian?
- Can a pushchair or wheelchair pass my vehicle without having to go onto the road?
- Is there enough room for other vehicles to pass safely?
- Am I parked on white lines, no parking or keep clear road markings?

# If the answer is yes to any of these questions, PLEASE find somewhere safer to park.

#### Dogs on the Allotments

Unfortunately, the Council has received several complaints about dog owners allowing their dogs to roam freely on the allotment sites. Please note that if you are walking through any of the allotment sites <u>all dogs MUST be kept on a short lead.</u>
PLEASE

- DO NOT allow your dog to stray onto the allotment plots.
- ENSURE you clean up after your dog.

Please be aware that allotment tenants may use products on their plots that could be harmful to dogs if ingested.

#### Annual Return 2023/24

The internal Audit of the Accounts for the year 2023/24 has been completed. The Council approved the Annual Return for the year ending March 2024 at the May 2024 Council meeting. The Accounts have now been submitted to the external auditor PKF Littlejohn LLP.

Council hereby gives Notice of Public Rights and Publication of Unaudited Annual Governance and Accountability Return for the Accounts for the year ended March 2024.

Any person interested has the right to inspect the accounting records for the financial year to which the audit relates. The documents will be available on reasonable notice by application to the Clerk. The inspection period is 30 working days, commencing 28<sup>th</sup> June 2024, and ending 8<sup>th</sup> August 2024.

### Buckinghamshire Best Kept Village Competition

Edlesborough and Dagnall villages have entered the Buckinghamshire best Kept Village Competition. Judging will take place in June and July.

#### NMJ Planning Applications

On 23<sup>rd</sup> May Buckinghamshire Council approved the following application - 23/02966/APP Change of use to retail convenience store including associated external alterations, plant equipment, parking, and servicing area, 2 Pebblemoor Edlesborough Buckinghamshire LU6 2HZ. The following conditions were included as part of the approval

- The deliveries and collections serving the retail use hereby permitted, including refuse collection shall only be carried out between the hours of 07:00 to 19:00 hours daily.
   Reason: To protect the amenities of the nearby neighbouring properties, in accordance with Policy BE3 of the Vale of Aylesbury Local Plan (adopted September 2021), and the National Planning Policy Framework (2023).
- The retail use hereby permitted shall only be open to customers between the hours of 07:00 hrs and 20:00 hours daily.
   Reason: To protect the amenities of the nearby neighbouring properties, in accordance with Policy

BE3 of the Vale of Aylesbury Local Plan. The full approval document is available to view on the Buckinghamshire Council website.

At the time of writing this report the following application is still awaiting a decision -

23/02884/APP Erection of a commercial building for MOT and Car Service Centre, under Class B2 use N M J Motorhouse Tring Road Edlesborough Buckinghamshire LU6 2EQ.
